Her background is in the civil service where she also had senior roles in HMT and DfE. Charlotte started her career as an economist before moving to wider policy roles. Her work included leading the initial work on automatic enrolment. I feel sure Charlotte's talk will prompt plenty of discussion and debate given the number of pensions change on the horizon.

"CDC – the debate continues"

To round off the meeting we have what promises to be a very lively discussion on the pros and cons of CDC. The panellists really need no introduction as with the exception of Michael Jones they've all been speakers, members of the advisory board or regular attendees at TPNW over many years. Michael comes highly recommended. He is a partner at Eversheds specialising in DC schemes. The Pension Schemes Bill contains regulations on CDC with the first multi-employer scheme possibly in place by the end of 2026. There is also a consultation underway on Retirement CDC schemes. So there will be no shortage of material to talk about and I suspect some differing views amongst the panellists on just how popular the new versions of CDC will be – and how quickly they may be delivered. It should make for a great concluding session.
